

Sample Bequest Language

Boys & Girls Clubs of America

In order to make a bequest, you should speak with your attorney. Your attorney can help you include a bequest to Boys & Girls Clubs of America in your estate plan. We have provided some basic bequest language to assist you and your attorney.

1. Percentage Bequest

If you are considering making a bequest of a percentage of your estate to Boys & Girls Clubs of America, we recommend the following language:

2. Specific Bequest

If you are considering making an outright bequest to Boys & Girls Clubs of America, we recommend the following language:

Bequest of Specific Personal Property

I hereby give, devise and bequeath DESCRIPTION OF PROPERTY to Boys & Girls Clubs of America, a nonprofit organization located at 1275 Peachtree Street NE, Atlanta, GA, 30309, Federal Tax ID #13-5562976, for Boys & Girls Clubs of America's general use and purpose.

Bequest of Specific Real Estate

I hereby give, devise and bequeath all of the right, title and interest in and to the real estate located at ADDRESS OR DESCRIPTION OF PROPERTY to Boys & Girls Clubs of America, a nonprofit organization located at 1275 Peachtree Street NE, Atlanta, GA, 30309, Federal Tax ID #13-5562976, for Boys & Girls Clubs of America's general use and purpose.

3. Residual Bequest

I hereby give, devise and bequeath to Boys & Girls Clubs of America, a nonprofit organization located at 1275 Peachtree Street NE, Atlanta, GA, 30309, Federal Tax ID #13-5562976, ALL OR A PERCENTAGE of the rest, residue and remainder of my estate to be used for Boys & Girls Clubs of America's general use and purpose.

4. Contingent Bequest

If (primary beneficiary) does not survive me, then I hereby give, devise and bequeath to Boys & Girls Clubs of America, a nonprofit organization located at 1275 Peachtree Street NE, Atlanta, GA, 30309, Federal Tax ID #13-5562976, DESCRIPTION OF PROPERTY to be used for Boys & Girls Clubs of America's general use and purpose.
